The Netherlands

Adding value by logistics innovation and sustainable supply chain



With a long history in international trade, its strategic location and excellent transport infrastructure, including the Port of Rotterdam and Amsterdam Schiphol Airport, the Netherlands is often considered to be the logistics Gateway to the European market. In the past decades many international companies have chosen our country as location for their European distribution centres, benefitting from the Dutch business friendly tax and customs regime and its well-educated, English speaking labour force.

Priority sector

The transport and logistics sector is crucial to the Dutch economy and is considered to be one of the priority sectors by the government. As a result of the growth in E-commerce, the sector's contribution to the economy has grown to around 10% of GDP and the sector represents roughly 10% of the labour market.

Innovation

The sector is also an important driver for innovation in the country. Innovations in supply chains globally share the common goals of improving efficiency, resilience, and sustainability. Like many other Western economies, in the past years, the Netherlands has been faced with scarcity of space and labour and increased regulatory requirements, which led to a sharp growth in the in the use of robotisation, automation and digitisation in logistics operations. Many large distribution centres use robots or automated systems for order picking and AI is transforming supply chains with game changing insights.

Sustainability

The European Union has very ambitious sustainability goals. We are committed to the Paris Climate Agreement, aim to become a circular economy by 2050, aim to reduce CO_2 emissions by half in 2030 (compared to 1990) and many cities will become emission free by 2025. The Dutch logistics sector plays and important role in meeting these ambitions and is committed to take its responsibility. Most new distribution centres meet the highest standards for sustainability and energy efficiency, many companies are shifting towards CO_2 neutral transport, and the use of reusable packaging and better coordination of logistics processes through data sharing, are on the rise.

Opportunities

In the Netherlands, we believe that global challenges are best solved together. And all these developments bring exciting opportunities for Chinese and Dutch companies to collaborate. Exporters looking to set up or restructure their European supply chains will find the latest supply chain solutions for the efficient distribution of their products to the European market. And suppliers of logistics solutions for robotisation, automation, digitisation and sustainability, will find a very large, vibrant and ready market with a good opportunity to grow.

As the Holland International Distribution Council, we are excited to bring a logistics delegation to China, with representatives of Dutch companies that stand at the forefront of this wave of logistics innovation. During this trade mission, which includes our participation to the China International logistics Fair in Shenzhen and a visit to Shanghai and Ningbo, we look forward to meeting with Chinese companies and organisations with international ambitions, and discussing how we can support their plans.

荷兰

通过物流创新与可持续供应链创造价值



荷兰拥有悠久的国际贸易历史、优越的战略地理位置以及包括鹿特丹港和阿姆斯特丹史基浦机场在内的卓越交通基础设施,因此常被视为通往欧洲市场的物流门户。过去数十年间,众多国际企业选择将荷兰作为其欧洲配送中心的所在地,享受荷兰亲商的税收和海关制度,并获益于其受过良好教育、通晓英语的劳动力。

重点产业

运输与物流业对荷兰经济至关重要,被政府视为重点产业之一。随着电子商务的增长,该产业对经济的贡献已提升至约占国内生产总值(GDP)的10%,并占据了劳动力市场约10%的份额。

创新

该产业也是荷兰国内创新的重要驱动力。全球供应链创新的共同目标是提高效率、增强韧性与可持续性。与许多其他西方经济体类似,过去几年荷兰面临着空间与劳动力短缺以及监管要求提高的问题,这推动了物流运营中机器人化、自动化与数字化应用的急剧增长。许多大型配送中心使用机器人或自动化系统进行订单拣选,而人工智能(AI)则凭借其颠覆性洞见正在重塑供应链。

可持续性

欧盟制定了雄心勃勃的可持续性目标。我们致力于履行《巴黎气候协定》,力求到2050年实现循环经济,目标在2030年将二氧化碳排放量减少一半(相比1990年水平),并且许多城市将在2025年前实现零排放。荷兰物流业在实现这些目标中扮演着重要角色,积极承担责任。大多数新建配送中心都符合最高的可持续性与能源效率标准,许多企业正转向碳中和运输。可循环包装的应用以及通过数据共享优化物流流程协调的做法也日益普及。


